#### **Meeting Minutes**

- I. Call to Order/Introductions Carrie Camp, RS
  - A. The meeting was called to order at 5:49 pm
  - B. Attendance was taken. It was determined that a quorum was met.
- II. Approval of the February 2022 Regional Council Meeting Minutes
  - A. Carrie Camp asked if there were any changes to the minutes.
  - B. MOTION: Michelle Arnold made a motion to accept the February 2022 Regional Council Minutes. Motion was seconded by Karen Souder.
  - C. VOTE: the motion passed unanimously.

- III. RS Report on General Status of Region & Financial Status Carrie Camp & Michelle Arnold (Attachment)
  - A. Carrie Camp reported that the financial status of the region is very strong. She noted that the regional treasurer was not present so she would be presenting the financial information.
  - B. The region has approximately \$48,000 in cash (and other assets including 2 trailers).
  - C. Rallies Carrie Camp noted that the rallies are budgeted as a group to breakeven. This year ended with the rally category in the black. She noted that at the February Regional meeting rally fees will be set and how to manage the rallies either as a group or individually. She noted that Quiz usually makes a profit while others run at a loss, but as a category, rallies usually break even. Carrie Camp asked for questions, none were presented.
  - D. Michelle Arnold reviewed the line items from the 2022 Financial statement.
  - E. Carrie Camp noted that she would like to take over one of Casanova-Warrenton jumper shows if there is an opportunity. It would be a fundraiser for the region. Regarding why the region needs to raise funds, she noted that in 2015-2016 the region was losing \$8,000-\$10,000 on rallies and reduced the region's operating budget to barely \$20,000, below the recommended amount of a 2-year operating budget. She noted that she had to trim rallies in the following years. She noted that the reason we are doing well is due to how strictly we manage rallies and we receive funding from Horse Industry Board. The Horse Industry donation of \$5,000 paid for a venue and the rally ribbons. Michelle Arnold noted the funds raised at a jumper show could be used to defray cost of putting on a National test in Virginia which is expensive. And would help with funding if the Horse Industry Board funding was to go away. Carrie Camp also noted supports the idea of hosting a National Test in Virginia which provides a local location for VA region candidates.
  - F. Certifications Carrie Camp noted that USPC pays travel expenses for examiners. The host Region pays for lodging, meals, facility fees. USPC rules also says candidate fees can not exceed \$175. Stabling can be charged separately. Carrie noted that she feels the need to host a national test because there are very limited opportunities for candidates to test within a easy travel distance (the most local national test at Fair Hill usually has very limited slots).
  - G. USPC Champs Carrie Camp mentioned that the fees for champs paid to USPC has not changed for many years and the USPC fees are just 1 part of the cost for going to Champs. Other costs include hotel, meals and region fees. She mentioned that VA Region has traditionally hired coaches for the VA Region competitors at Champs. The coaches fee is added to the cost each competitor is paying VRPC for Champs. VA Region covers the costs of lodging, food, travel as well for coaches. In last few years, regional officers have paid their own lodging, food and travel and not charged the region. Shirt income is balanced by the shirt expense. Regional fees covers the pre Champs picnic, coaches fee, saddle pads, pizza party, shirts.
  - H. Michelle Arnold reviewed all items in 2022 Financial Summary report.

- ii. National Testing \$2,500
- iii. Regional Testing \$2,000
- iv. Regional Instruction Program \$4,000
  - a) Region is planning several instructions sessions with Cathy Frederickson for HB prep and HA prep.
- v. Rally Expenses \$30,475
- C. Discussion
  - i. The \$3,000 net assumes that Horse Industry funding is received.
  - ii. Carrie Camp noted that the budget assumes that venue fees for rallies are between \$2,000-\$3,000. She noted some venues are fee like Copperfield Farm.
- D. MOTION: Alice Johnson moved to accept the budget as presented. It was seconded by Julie Muniz.
- E. VOTE: The motion passed unanimously.
- VI. Nominating Committee Report Stefanie Cosenza
  - A. Nominating Committee was Stefanie Cosenza, Alice Johnson and Jo Hunt.
  - B. Two regional position replacements are needed: Secretary and Horse Management Officer.

- D. MOTION: Stefanie Cosenza made a motion to accept the officer slate as presented. Michelle Arnold seconded the motion.
- E. VOTE: the motion was passed unanimously.
- VII. 2023 Calendar *Carrie Camp, RS (Attachment)*

The proposed calendar was presented & reviewed. Carrie Camp noted that she worked hard to plan only 1 rally per month.

A. Tet Rally – Carrie Camp noted that Tet rally is moved to August, so we may get an outdoor pool. Clark County Fair Grounds was suggested or Great Meadows. That means anyone wanting to qualify for champs this year will need to go to another rally. The Maryland Tet rally is usually in June. If the region prefers Tet to stay in the spring, Carrie Camp has a date reserved in May at Deep Run. Carrie Camp noted that Blue Ridge Hunt is not able to run this rally as hoped so another club will need to take it over.

- B. Rally Management Carrie Camp noted when she took office rallies were losing money. She and Michelle stepped in and have been planning rallies since. She also noted that Michelle A has been doing all of the secretary work for rallies. She stated it is time for she and Michelle A to step down from the rally planning and management. Going forward Carrie Camp wants to have lead hosts for every rally and looking for lead host to organize the rally (secretary, scheduling ride times, organizing stabling & volunteer coordination). The region will continue to secure the officials, venues and hotels to help control costs. Carrie Camp noted several clubs already do a great job with rallies they manage.
- C. Quiz Rally Carrie Camp noted new management is coming to Frying Pan Park and they have not told us if we get the venue for free. We may need to pay them a fee.
- D. Horseless Rally will be at Morven Park.
- E. Morven Park HT Carrie Camp noted that clubs should avoid planning around Morven Park HT. Aldona Petraitis also pointed out that for Horseless Rally, Morven doesn't charge for use of the facility. So volunteering at their horse trials keeps Morven friendly toward pony club.
- F. Eventing Rally will be held in conjunction with Deep Run Hunt HT (unrecognized HT.
  - i. VA Region competitors pay HT entry fee and stabling fee with stabling in a separate barn. HM will run as normal.
- G. Show Jumping Rally Carrie Camp noted it is back at Deep Run Hunt. Carrie Camp received comments that coaches and the TD needs to see both rings. Michelle A noted that we need a venue where there is stabling, where the coaches and TD can see both rings and where there are jumps available. Carrie Camp also noted there are reasonably priced hotels close by as well.
- H. Dressage Rally at Frying Pan Park. Carrie Camp noted that we need to figure out how to stage it.
  - i. Need to determine if we do a 1 day or 2 day rally.
  - ii. If it is a 2 day rally there is more down time and we could get away with 3 rings.
- I. Discussion of the calendar optionsCarrie Camp asked if Misty Brae Farm could host Horseless Rally at Morven Park. Tori Hutcheson said that she would check her calendar and that a Saturday is better for her. Michelle Arnold offered to assist with the rally organization.
  - ii. Carrie Camp noted that Tet rally would be in August and run it as a 1 day. The hardest part is getting a pool. Julie Muniz noted that the older kids trying to qualify for Tet prefer a 2 day rally. Carrie Camp noted that the Maryland region Tet is a 2 day rally which should satisfy them.
  - iii. A question was asked about the budget for pools for Tet rally. Carrie Camp noted that we have always been able to get pools for free at the Warf in Warrenton & YMCAs at Deep Run. Shooting is the main issue because some locations won't let us shoot (ex. Frying Pan, Warrenton Show Grounds prohibit shooting).
- J. HB Series & HA Series a series of prep sessions based on the title "Exceeds Standards Prep" will be presented by Cathy Frederickson.
  - i. Locations could include MARE Center, TriCounty, PATH Center in Warrenton.
  - ii. Timeframe will be early 2023 for HB series and in June for HA.
- K. D Rally Possibly at Copperfield in June again this year.
  - i. Alice Johnson noted that her club will be meeting soon to discuss and will let us know.
  - ii. Carrie Camp asked if D Rally in June would work. Julie Muniz noted she prefers it in Sept so that D kids can have all summer to get their skill level up.
  - iii. Michelle Arnold suggested that Red Gate might be a possible location.

- iv. Kate noted that Red Gate is challenging because Dressage warm up is on grass.
- VIII. USPC Annual Fund Challenge Carrie Camp proposed that the region increase the budgeted donation to USPC Annual Fund in order to increase chances of winning the Annual Fund Challenge. The winning region will receive 10% of total its donations back.
  - A. Carrie Camp proposed an increased amount of \$750.
  - B. Members asked for clarification on if donations from the region's clubs/centers count toward the region amount. Carrie Camp confirmed that it does.
  - C. Carrie Camp reminded members that USPC cost for each member is \$300; but charges a fee of \$165. So the Annual Fund bridges the gap. She noted that the key for USPC is high level of participation in the Annual Fund.
  - D. Last year the VA Region was 8<sup>th</sup>. Michelle Arnold noted that as of today the VA Region is now at \$2,870 in donations to annual fund.
  - E. MOTION: A motion to increase the budget to \$750 was made by Alice Johnson. It was seconded by Julie Muniz.
  - F. VOTE: the motion was passed.
- IX. National Youth Congress (NYC) Nominations Carrie Camp, RS
  - A. Carrie Camp presented 2 candidates: Grace Speed from Deep Run Hunt, is an active HB member, and Vicktoria Petraitis from Loudoun Hunt, a C+ member. She noted that both have been outstanding members in terms of leadership and volunteering.
  - B. Aldona noted that Viktoria is excited to participate. Julie Muniz noted that Grace is the epitome of what you would think of as a good pony club candidate.
  - C. Carrie Camp noted that VRPC will cover costs of NYC participants for travel & food & registration fee. The NYC meeting is before the USPC Annual Meeting.
  - D. MOTION: A motion to accept both candidates was made by Michelle Arnold. It was seconded by Brook Sterns.
  - E. VOTE: the motion was passed unanimously.
- X. Champs and Coaching Carrie Camp
  - A. Carrie Camp explained that this year at Champs the region staff received some unusual requests from parents requesting a "45 minute lesson" prior to their time to compete. It was noted by Aldona Petraitis that Champs is not the place for a "lesson" and that competitors should not expect that.
  - B. Carrie Camp mentioned that at Champs about ½ of the regions manage the coaches for their competitors and ½ of the regions do not. She noted that USPC rules are that only SJ requires a coach be present for each rider & the team cannot be submitted without a coach named. Carrie Camp said it is a benefit for the region to organize and hire the coaches, however, the competitors pay for it.
  - C. Carrie Camp noted that coaches do not make money at best they cover their expenses. She also noted that even with hiring coaches the region had to ask another coach to pitch in last year. Tori Hutcheson stepped in to coach a couple of kids because the ride times conflicted and the rings were moved due to weather, making it impossible for the paid coaches to be at the ring for a few of our competitors. Carrie Camp thanked Tori Hutcheson and noted she did a great job with the competitors.
  - D. Carrie Camp asked the group to go back to their respective clubs and discuss how they would like to handle hiring coaches for next year Champs. Do the clubs want the region to continue to manage the Champs coaches or would they prefer to hire/manage at the club level? She noted that the region will vote on this issue at the February meeting.
  - E. Discussion
    - i. Aldona Petraitis said suggested that the region might consider hiring a third coach.
    - ii. Carrie Camp noted she would try to hold costs if possible.

- iii. Michelle Arnold said she thinks it is time for a change and that clubs should bring their own coaches. She noted a few reasons: 1) parents aren't happy about how it is done, 2) it is a lot of work for the region staff, 3) maybe having region hire/manage Champs coaches is not the best way to handle it.
- iv. Tori Hutcheson suggested that if a club or member brings their own coach, the region coaching fee should be less. She noted that our coaches do a great job, but it is a big job and they must cover a lot of territory on a very large venue. Michelle Arnold noted that it is hard to budget with a reduction in fees and may turn out with not enough funds to pay the coaches that are hired.
- v. Julie Muniz said she would prefer to pay more and hire another coach.
- vi. Carrie Camp thanked everyone for their feedback and noted that she is hesitant to lose money on Champs since it is a personal achievement event versus the rallies which all members may attend.
- vii. Michelle Arnold noted that VRPC fees for coaches have been Eventing, Show Jumping members pay \$250 for the coach fee & Dressage & Tet pay \$200. The coaches were paid \$1,700 plus the Region covers food, travel and housing costs.

#### XI. New Business -

- A. Kate Aytes noted that Snickersville Hunt is hosting a National Jr Fox Hunting Field Master Trial in Middleburg. An email was sent to VRPC leaders. Michelle Arnold added that the Junior North American Field Hunter Championship (JNAFHC)has a good website and Facebook page to check out.
- B. Carrie Camp thanked Cindy Shelberg, region Secretary for her many years of contribution to VPRC.
